Green Hydrogen Agenda Process

In 2020 the European research ministers agreed to launch a joint R&I-initiative on Green Hydrogen as an ERA (European Research Area)-pilot action. You can find more information about this initiative [here](#). In three thematic areas a so-called “Agenda Process on Green Hydrogen” identifies urgent research and innovation questions for Green Hydrogen competitiveness. The Austrian Federal Ministry for Climate Action, Environment, Energy, Mobility, Innovation and Technology (BMK) took over the responsibility for the market stimulation topic.

Market Stimulation Green Hydrogen

Market stimulation comprises all measures that support the development from no (or few) offer and demand to a fast growing “Green Hydrogen” market, eventually substituting fossil based energy carriers and feedstock. According to the two basic pillars of the process, we have chosen the motto “Overcoming barriers by collaboration” as a working title for the event on 22nd of October 2021.

The market stimulation online event on 22nd of October 2021 will consist of two parts – a public part (keynotes and panel discussion) and a workshop with a limited number of participants. A broad participation by stakeholders from different countries and affiliations (civil society, science and industry, public authorities) is appreciated.
